Call to Order: Dr. Moylan called the regular meeting of the Board of Health (BOH) to order at noon.

Jessica Clarke Manderville, the new Director of Children with Special Care Needs, introduced herself to the Board. She previously worked with Ms. Buckwalter in the Division for Community Health as a Senior Community Health Nurse.

Privilege of the Floor: None

Approval of December 5, 2023, Minutes: Dr. Dhundale moved to approve the December 5, 2023, minutes; second by Ms. Touchton. The vote to approve the December 5, 2023, meeting minutes as written was unanimously approved; the motion carried.

Financial Summary: Mr. Kruppa said that Ms. Brenda Grinnell Crosby has transitioned into the role of Deputy Public Health Director. Fiscal Administrator, Jeremy Porter, will now provide the financial summary reports. Mr. Porter returned from a medical leave today and will be present at future meetings. He said that the staff is currently working to close the books for the 2023 fiscal year and is not aware of any major concerns.

Medical Director's Report and Discussion: Dr. Klepack referred to his report included in the packet with a note to significant changes in Anaplasmosis and Lyme disease from ticks in the region. Syphilis numbers decreased and were much better than in previous years. COVID-19 hospitalizations also decreased. Influenza is consistent in its fluctuation. It is Radon Awareness Week and free radon kits are available on the county website Radon | Tompkins County NY and the NYS webpage Radon (ny.gov). Testing is recommended.

Ms. Hillson added that a press release is going out about Radon Awareness Week and there will be information on where to find free radon kits. They can also be purchased from local hardware stores.

Administration Report: Mr. Kruppa said that the strategic planning process is well underway and is launching a staff input survey. The BOH members will also receive a survey to provide their feedback. The Winter All-Staff Meeting will be held on January 31, 2024, at the Mental Health Building.

The New York State Budget Hearing on Health is today. There is a proposed 5% rate increase for Early Intervention (EI) services with an additional 4% for rural and underserved areas. It was not clear if it would apply to Tompkins County. The proposed cuts may include \$50,000 from our rabies program. Some other

EI services may not be funded but all cuts will have minimal impact on the current services. There were discussions of workforce shortages across the State. They will continue to monitor the State Budget process and provide updates to the Board.

Division for Community Health (DCH) Report: Ms. Buckwalter had nothing to add to her written report included in the packet. There are two open positions for senior community health nurses that have been posted on the website.

Health Promotion Program Report: Ms. Hillson had nothing to add to her written report included in the packet. She said that this is Radon Awareness Week.

Children with Special Care Needs (CSCN) Report: Jessica Clarke Manderville, the new Director of Children with Special Care Needs, is being trained by former Director, Deb Thomas, for a short time. She expects to have a report available at the next meeting.

Environmental Health Report: Ms. Cameron reported that they are investigating an incident where people became ill at a private pool party held at the Holiday Inn in December. The investigation includes EH and NYSDOH.

NEW BUSINESS:

ADMINISTRATION

Administrative Actions - Election of BOH President and Vice President

Mr. Kruppa opened the floor for nominations for the elections for president of the BOH. There were no other nominations from the floor. Dr. Christina Moylan was nominated as the President of the Board of Health for 2024. All were in favor, and it was unanimous.

Mr. Kruppa opened the floor for nominations for the elections for vice president of the BOH. Dr. Dhundale moved to nominate Dr. Dhundale as Vice President of the Board of Health, seconded by Ms. Black. Dr. Dhundale was nominated as Vice President of the Board of Health for 2024. All were in favor, and it was unanimous.

ENVIRONMENTAL HEALTH

Enforcement Actions:

Resolution #EH-ENF-23-0014 Revision 2 – Cayuga Nature Center, Violations of Subpart 7-2 of New York State Sanitary Code (Children's Camp) – Ms. Touchton moved to accept the motion as written; seconded by Ms. Merkel.

Ms. Cameron explained that this was a violation of previous BOH orders. Cayuga Nature Center is not currently in operation and is experiencing financial difficulties. This order removes the previous deadlines before making changes to their water system and requires them to make changes 60 days before operation. They are working with a water supply contractor to correct the problem before opening in the summer.

All were in favor; the vote to approve the resolution as written was unanimous.

Resolution #ENF-23-0026 - Holiday Inn Express Pool, Violations of Board of Health Orders and Subpart 6-1 of the New York State Sanitary Code (Swimming Pool) – Ms. Merkel moved to accept the motion to as written; seconded by Ms. Touchton.

Ms. Cameron explained that this was a violation of previous BOH orders. An inspection in October 2023 found the pool was in operation when it should have closed, hence, violating the code. EH expanded the order and added requirements for designated staff to take the pool operations course as well as to be on-site. They have submitted monthly operating reports, and a designated person is currently taking the pool operation course.

Discussion: Ms. Cameron clarified that the pool is currently open, a clean inspection in January and Holiday Inn Express contracted a person trained in the pool operation to come bi-weekly.

All were in favor; the vote to approve the resolution as written was unanimous.

Executive Session: At 12:25 pm. Dr. Dhundale moved to adjourn to Executive Session, to discuss potential litigation, seconded by Dr. Koppel; the motion carried unanimously.

Out of Executive Session and Adjournment: At 1:05 pm Ms. Merkel moved to adjourn the Executive Session, and Adjourn the meeting, seconded by Dr. Koppel; the motion carried unanimously.


Practitioner Bulletins

While the schedule of these bulletins remains rather fluid, they have settled into a once to twice-amonth pattern. The most recent bulletin was 02/12/24. For updates on a variety of topics of current importance, I draw the Board's attention to them.

Trends in influenza and Covid

INFLUENZA

Fluctuation without significant decline – remains widespread. Influenza type B's progressive increase is shown here (a predictable occurrence as the season advances):

In years wherein H1N1 predominates (as in this one), severity is usually higher.

COVID

You may have seen the news about the CDC possibly dropping their isolation guidelines for COVID to make it match what is said for flu and RSV. For now, these are just news reports about what the CDC plans to do, but the CDC hasn't done anything yet. (At least as of when I'm typing this.) If you missed any of this in the news, here's a link: https

The **COVID variant** page has a new addition—variants that are detected in wastewater. You can now see the predominant strain circulating in wastewater by the sewer shed. You can see some breakdowns if you hover your cursor over the sewer shed. https://coronavirus.health.ny.gov/wastewater-variant-data.

The Cayuga Heights treatment plant is the one reporting variant data in our county. It shows JN1 as the predominant type. The rise in the JN1 family of variants can be seen in the graph <u>posted in the appendix</u>.

The variants being detected are still manifesting the same clinical characteristics as the ones over the last six months and testing modalities remain valid.

Communicable Disease Report

YEAR TO DATE (YTD

Note that in the YTD reports we receive that that metric only applies to the current year. The data for previous years is not year-to-date in the sense of being numbers up through the last complete month but, rather, are numbers for the entire calendar year.

In contrast, the Monthly CD report does report cases arising only in that month in previous years.

Respiratory Syncytial Virus (RSV) has only recently become a reportable disease in NYS. As such the data is still going through refinement. You will note in the following chart that 2021-22 show no cases. This is only because it was not reportable. Beginning in Dec reports started to be collected. RSV "season" is expected to wind down in March.

No other categories of disease seem to need comment as the trends are similar to those reported in my recent Board reports.

Regarding *tick borne disease* we see that Lyme remains a problem in these warm winter months with cases arising in our population either from travel to other areas or from exposure in our region. This is an example of climate change promoting disease.

Selected disease rates are shown in the MD section of the Appendix.

MEASLES RECENT CASES IN NYS -

One case in a child under 5 who traveled to two Arabic Middle Eastern countries. The child was not vaccinated. Otherwise, in 2024 NYC has had 3 cases since the end of 2023. (all travel-related). Of the 3 one, they had had one documented dose which was done outside of the US. The others were unvaccinated. Regional residents of ours who are inadequately vaccinated are urged to get their measles vaccination.

MPOX

NYC is seeing an increase in cases = 25-30 cases each month since late fall. Practitioners are urged to have a low suspicion for testing. Hopefully, MPOX doesn't migrate north. To date, we have only had 5 cases diagnosed in the rest of NYS.

TOXOPLASMOSIS

multiple persons downstate became ill after going to a <u>"game dinner"</u>. Approximately 150-250 people each night over a couple of nights at a private event ate venison which was served undercooked or even raw (by interviews with attendees). Flu-like symptoms were common. White-tailed deer are a common source of toxoplasmosis (a parasite) and the most common route of exposure is consumption of undercooked meat. Typically, exposures lead to about 10% of persons

being symptomatic. 1 pregnant and 3 immunocompromised people are known to be infected at this time. Infected fetuses can have significant damage. Immunocompromised people are at risk of uncontrolled infection.

From the CDC: "Toxoplasmosis is considered to be a leading cause of death attributed to foodborne illness in the United States. More than 40 million men, women, and children in the U.S. carry the Toxoplasma parasite, but very few have symptoms because the immune system usually keeps the parasite from causing illness. However, women newly infected with Toxoplasma during or shortly before pregnancy and anyone with a compromised immune system should be aware that toxoplasmosis can have severe consequences. Toxoplasmosis is considered one of the neglected parasitic infections of the United States, a group of five parasitic diseases that have been targeted by CDC for public health action."

REGARDING HARM REDUCTION AND THE SPECIFIC STRATEGY OF OVERDOSE PREVENTION CENTERS

In the past month, I have been in conversation with Frank Kruppa, John Barry of STAP, Dr Justine Waldman of Reach Medical, and Toni Smith of the Drug Policy Alliance. Many harm reduction initiatives have been accomplished, some are in progress, and (regarding Opioid Prevention Centers) some are not at a point of being able to be employed. One issue that remains clear is that our community could benefit from further discussion regarding harm reduction. Specifically, information is needed to dispel misconceptions about it. Accordingly, I will plan on doing several presentations on the topic in the coming year to interested community groups. The first of these will be a presentation at Lifelong as part of their ongoing lecture series. The date is April 9th at 10 am.

ORAL HEALTH IN TOMPKINS COUNTY

Due to the excellent work of Sagarika Vemprala, BDS, MPH, Communicable Disease & Dental Public Health Graduate Fellow, and the able support of Rachel Buckwalter, RN, BSN, Director of Community Health, we have begun a survey of children in Tompkins County regarding the state of their oral health. The survey is distributed through the school districts of the county, and we greatly appreciate their interest and help in this. The data from the survey will provide a current indication of needs and from it appropriate strategies should be suggested. Click here to visit the Oral Health page on our website.

Current concerns summarized

Although my bulletin provides extensive information, I believe it is helpful to underscore in this public document a few points.

- Measles the current global increase in measles cases and the occurrence of some in some states of the U.S. underscores the importance of measles vaccination. Levels of about 95% are necessary to control the spread of measles in a population. In some regions of our state and of our county this level of vaccination is not being achieved. We/I recommend every eligible child and adult know their vaccination status and ensure they are adequately vaccinated.
- Radon The prevalence of radon in homes and businesses is so high in our region that every building should be tested (the only way to know if this cancer-causing, colorless, and odorless gas is present in your indoor air). Such kits are available for purchase at hardware stores, for free through our Healthy Neighborhoods Program, and by going to https://www.health.ny.gov/environmental/radon/) Go to our Whole Health radon webpage for more information.

Whole Health Highlights

- The RFP for Innovative Housing Solutions and Intensive Supports was completed and posted for proposals (due 2/23/24).
- Construction in the CHS/Mental Health wing is nearing completion. The next step will be to get the space approved by the Office of Mental Health. Office moves on the second floor are underway.
- We have entered the third and final phase of our Strategic Plan revamp process! Phase 1
 included an SLT day-long retreat to identify and order the priority areas (PAs), as well as the key
 result areas (KRAs) within the PAs. Phase 2 included 3 separate Supervisor Review Sessions to
 identify and order our action steps. We are now collecting feedback from staff and stakeholders,
 please take the time to provide feedback if you haven't done so already.

Shared Topics Update

Strategic Planning/Merger

CULTURE:

Align the organization around our shared mission and values-based culture to create an empowered, engaged, and cohesive team.

- We welcomed Dr. Jamila Michener (<u>Cornell bio</u>, <u>Professional bio</u>) as our guest speaker at our 1/31 event. She spoke to us about structural racism: what it is, and how it impacts us and our community. We will be continuing this discussion at our 3/5 All-Staff virtual training hour!
 - Additionally, several TCWH staff are planning to attend a community health equity event ("Working Together to Achieve Health Equity") moderated by Dr. Michener. The flyer is attached in the appendix.
- Our DEIB Cross-functional Team is continuing to explore opportunities within TCWH to cultivate
 DEIB opportunities and practices. The group has been working to access and discuss
 demographic information internally (of staff) and externally (of clients) and are working to
 identify better systems or pathways for data monitoring/collection/analysis.

INTEGRATION:

Merge the department structures to become one organization and increase our ability to better serve our clients and community.

 We held our bi-annual All-Staff event at our Green St. location on 1/31! Staff spent the day learning with and from each other. The theme for the day was 'Winter Wonderland'... Staff

- kicked off the morning with mingling and enjoying a hot cocoa bar, then tuned in to a presentation from Dr. Jamila Michener. Following the presentation, teams rotated throughout several professional development sessions throughout the day, with built-in breaks for fun activities such as Whole Health Trivia and a Whole Health scavenger hunt.
- At our Supervisor Development Session on January 17th, TCWH supervisors/SLT worked together to begin to build a 'TCWH Interview Question Bank' that supervisors could utilize during interviews. The development of this question bank is still in progress. At the next Supervisor Development Session scheduled for 3/5, we will be continuing our hiring discussions and will shift our focus to other parts of the hiring process.

Highlights

COMMUNICABLE DISEASE

- In the month of January, one case of Yersiniosis (related to travel to Peru), one case of Shigella (related to travel to India) and one case of Dengue (related to travel to the Dominican Republic) were reported. All patients are recovering with no complications.
- There was one case of invasive Strep Pneumoniae reported which resulted in a week-long hospitalization. The patient was discharged home on oral antibiotics.
- There was one case of Shigella reported which was not travel-related. The patient also had Covid at the same time and required hospitalization.
- See CD report for the data for all communicable diseases reported in the month of January.
- Varicella and RSV are now reportable diseases in New York State. See Appendix for a Health Alert from NYSDOH dated Dec 20, 2023, with more information on this.

STAFFING

WIC

TRAINING

- CHS nurses completed required mandated reporter training in January through OCFS. Two DSS caseworkers came to a CHS team meeting on January 18th to present on the changes to mandated reporting and answer questions about this process. Community Health Workers, WIC staff and CSCN staff joined CHS for this training.
- A SUNY Binghamton nursing student and a SUNY Delhi nursing student completed their community health clinical rotations in CHS in the month of January. Both were required to have 20 hours of community health clinicals which included learning about CHS programs and shadowing nurses to learn about our prevention-focused work.

Program Updates

SAFECARE PROGRAM

 One family is currently enrolled in this program and progressing towards completion. Regular meetings are occurring with DSS regarding case management of families in the program and discussion of new referrals.

IMMUNIZATIONS

• 16 patients were immunized in our on-site immunization clinic in January. Two homebound clients received vaccines in January as well.

MOMS PLUS+

- The Moms PLUS+ program continues to experience an increase in referrals. In December there were 52 referrals received for this program. In January we had 63 referrals to this program. Most of our referrals come from CMC Birthplace, OBGYN Associates and WIC.
- Moms PLUS+ nurses admitted 17 new clients to the program in January and completed 41 home visits in the month of January.

RABIES

 4 people were approved for rabies post-exposure prophylaxis in the month of January. Three of these exposures occurred out of state/country. One exposure was within Tompkins County to a dog that was unable to be identified/located.

LEAD

- CHS ordered and received books for children titled "Happy Healthy Lead-Free Me" which will be
 distributed to pediatrician offices and other community locations. These books use simple
 language to teach about the most common sources of lead exposure and how to avoid lead
 exposure for children and families.
- There are 16 children currently admitted in the lead program. There were no new admissions in the month of January.

HIV

• HIV testing is offered by a CHS nurse once a week at STAP and by appointment at 55 Brown Rd. During the month of January, one person was tested.

- Radon Awareness Week was January 22-26. Our <u>press release</u> garnered a lot of interest in the public seeking radon tests and Healthy Neighborhoods visits.
- CHIP Steering Committee kicked off our <u>MAPP 2.0</u> process on January 4, with a comprehensive overview of the handbook.

STAFFING

• Pat Jebbett completed her Project Assistant position with the Healthy Neighborhoods Program on 1/19/24. She is a great asset to the program, conducted many revisits, especially for homes with at least one person who has asthma.

Program Updates



Highlights

Janary Rabies Clinic: Environmental Health held our winter rabies clinic on January 17, 2024, at the Tompkins County SPCA. Registration for the clinic was fully booked over a week in advance of the clinic. Despite the cold and snow, 159 pets were vaccinate. Thanks and kudos to EH staff who worked the clinic: Cynthia Mosher, Rene Borgella and Scott Freyburger who managed people and pets moving through the clinic, rabies vaccination certificate writes B Walsh (EH Admin Assistant 3), Bonnie Hart and Jamie Breedlove (TCWH retireees), and Diana Crouch (TCWH Healthy Neighborhoods Education Coordinator). The clinic couldn't have happened without Cornell Veterinarian Dr. Brian Collins and Cornell Vet students Isaiah Morten and Diane Hwangpo.

Elevated Chlorine at a Hotel Pool. On December18, 2023, Environmental Health Specialist (EHS) Mik Kern received a report of illness stemming from a pool party that occurred on December 16 at a regulated pool. At least 9 of the 12 children attending the party became ill and visited the emergency department (ED) with various symptoms, including a strong cough, irritated eyes, stomach pain, headache, sore throat, and nausea. The likely cause was exposure to high levels of chlorine. The children were all released from the ED that night and had symptoms resolve within 1/2 to 3 days. EHS Mik Kern and Sr. EHS Kristee Morgan, in coordination with NYSDOH is conducting an illness investigation (contacting all involved or their caregivers) and working with the operator to correct the underlying issues. The investigation is open pending closure by NYSDOH.

The pool was closed voluntarily by the facility and immediately drained and refilled. Chemicals were rebalanced and monitored closely with an accurate test kit, and chemical feed equipment was checked to ensure that they were working properly over multiple days. The pool was re-opened after being inspected on January 4.

To Whom it May Concern,

Thank you for allowing the Argos Inn to provide context on the violations regarding the mishandling of combustible and flammable materials.

Throughout the 10 years we have been open for business we did know we had to keep certain flammables away but weren't aware to the extent of which we needed to. In speaking with the fire department about this matter, we were told that each inspector can have varying views on this topic. For example, prior to our visit in 2023 we were never flagged for having spray paint on our shelves. We acknowledge that we are in the wrong and did have items out on our shelves but we were running on the assumption that this was okay and were generally used to a more flexible view on this topic in particular.

When we were first flagged for the flammables in 2023, we promptly purchased a flammable safe cabinet through the recommendation of our inspector Kate. In her initial visit, all flagged materials were taken outside of the Inn during her visit.

Unfortunately, by our inspectors' second visit they had made their way back onto our maintenance shelves by new staff who didn't know about our inspection and why these items were placed outside of our maintenance area and outside of the Inn.

Throughout the years we have shifted between new staff, maintenance and managers. We understand that this can cause a misunderstanding in proper protocol. Avi, our owner, and Sarah, our Hotel Manager got together after receiving clarity on items that are combustible and flammable and came up with a plan to ensure nothing like this happens again in the future.

The only employees that will be handling these materials moving forward are our owner, maintenance manager and hotel manager. Verbal and written communication will go out to staff to ensure if they come across a material that is flammable or unsure about if the item is flammable they will seek one of the three direct people above before handling/moving the item.

By implementing our plan, we aim to ensure the safe handling and storage of combustible and flammable materials within the Argos Inn, thereby minimizing the risk of fire-related incidents and promoting a safe working environment for all staff members.

We appreciate you working with us on this matter. We feel confident that we have a solid plan going forward to keep flammables in our two fire safes.



New Respiratory Syncytial Virus (RSV) and Varicella Reporting Requirement Alert

Please distribute immediately to inpatient and outpatient clinical staff in Epidemiology, Infection Prevention and Control, Critical Care, Family Medicine, Emergency Medicine, Infectious Disease, Nursing, Internal Medicine, Pediatrics, Intensive Care, Pulmonary Medicine, Pharmacy, Pathology, and Laboratory Services

Purpose

Governor

The purpose of this notification is to communicate new reporting requirements for respiratory syncytial virus (RSV) and varicella. Effective 12/20/2023, laboratory-confirmed RSV in persons of any age and deaths caused by laboratory-confirmed RSV in persons younger than 18 years and all varicella cases (not shingles/zoster) are included in the reportable communicable disease list in New York State (Section 2.1 of Title 10 New York Codes, Rules and Regulations).

Introduction

The addition of laboratory-confirmed RSV in persons of any age and deaths caused by laboratory-confirmed RSV in persons younger than 18 years to the list of reportable conditions will result in more comprehensive and complete information on RSV activity, including being able to quickly detect where RSV is occurring, as well as specific strains that are circulating. The data will help anticipate hospital bed capacity challenges and help quantify the impact of newly approved RSV vaccines¹.

The addition of laboratory-confirmed and clinically diagnosed varicella to the list of reportable conditions will result in more comprehensive and complete information on varicella cases, including the ability to detect where varicella (not shingles/zoster) is occurring and to prevent spread in sensitive settings. The data will help to monitor trends, prevent disease transmission, and track the impact of vaccination over time.

Reporting Requirements

Respiratory Syncytial Virus (RSV)

Health care providers are NOT required to send laboratory specimens for suspected RSV cases and do NOT need to report individual cases of RSV or submit a confidential case report (DOH-389) to the local health department except for fatal pediatric RSV illnesses (see below).

Reporting of RSV cases will be via electronic submission from permitted clinical laboratories and limited-service laboratories approved by the Clinical Laboratory Evaluation Program. This regulation change is not intended or anticipated to result in any changes in clinical practice regarding RSV or RSV testing.

Pediatric Deaths Resulting from Laboratory-confirmed RSV

Health care providers must report cases of fatal RSV illness in pediatric patients younger than 18 years of age. An RSV-associated death is defined as a death resulting from a clinically compatible illness that was confirmed to be RSV by an appropriate laboratory or rapid diagnostic test, with no period of complete recovery between the illness and death. Health care providers should report any pediatric death resulting from a clinically compatible illness by telephone to the local health department where the patient resides². For patients who are residents of New York City, clinicians should report the death to the New York City Department of Health and Mental Hygiene (NYC Health Department) Provider Access Line at 1-866-692-3641.

Varicella

Health care providers must report all laboratory-confirmed or clinically diagnosed cases of varicella (not shingles/zoster) to the local health department of the county where the patient resides. Laboratory confirmation of clinically diagnosed varicella is recommended due to changes in epidemiology and clinical presentation since the introduction of routine childhood varicella vaccination; however, clinicians are NOT required by regulation to submit specimens. PCR of material from the base of an unroofed vesicle is the recommended test for laboratory confirmation. Varicella zoster virus (VZV) IgM is not recommended and no longer included in the laboratory criteria for the varicella case classification. Laboratory confirmation is important for public health efforts and interventions to prevent further spread of disease (e.g., verification of immunity, post-exposure prophylaxis, exclusion of susceptible contacts), particularly in congregate residential settings and other high-risk settings.

Regulated Healthcare Facility Reporting (Article 28 Facilities)

Healthcare facilities licensed under Article 28 of New York State public health law are required to report single cases of facility-associated (e.g., transmission within the facility) reportable conditions (now including RSV and varicella) and increases over the facility's baseline incidence of any disease. Reporting is required using existing mechanisms. Please contact the New York State Healthcare Epidemiology and Infection Control Program Central Office or the Regional Epidemiologist³ in the facility's region with reporting questions.
